#### Our offer for sex workers:

Step: obligatory health counseling at the public health office - specialized office for sexual health.
Step: Registration certificate according to §3 Prostitute Protection Act at the health office - district administration authority.

On a voluntary basis, the health office offers regular consultations and examinations for prostitutes; free of charge and anonymously if desired.

### 1. Mandatory health consultation according to § 10 Prostitute Protection Act

• Why do these consultations take place?

In order to start working as a prostitute, Section 10 of the Prostitution Protection Act requires a health consultation by the public health service.

The consultation is a prerequisite for the registration of the activity according to § 3 and may be a maximum of three months old for this purpose.

• Where do counseling sessions take place?

The counseling sessions take place in a confidential setting at Burgstraße 4 in the Health Office.

• When and how often do we consult?

We are happy to take the time necessary to answer all your questions. That's why you need a consultation appointment, which is best made in advance by phone.

If you are over 21, one annual appointment is sufficient. For ages 18 to 21, a semi-annual counseling session is scheduled. The duration of the consultation depends on the individual consultation needs and, based on experience, is 15 to 60 minutes.

• Who counsels?

Our counseling team consists of four experienced social workers and a doctor. In general, however, the consultations take place in private and in compliance with data protection regulations and confidentiality.

If there are problems with language comprehension, we have the possibility to spontaneously call in a video interpreter for many languages.

For other languages, we arrange a fixed appointment with the respective video interpreter.

• What topics does the counseling interview?

The counseling interview is adapted to the personal life situation and can have different contents. In particular, these include contraception, pregnancy, birth control, and the risks of alcohol and drug use.

But it can also be about questions of the general life situation such as family problems, desire to quit as well as coercive situations.

If necessary, we can put you in touch with the appropriate support services.

• What is the cost of the consultation?

There is a cost of 35 euros. You can pay by card or cash.

• Is there a certificate for the consultation?

Following the consultation, a certificate will be issued that is valid throughout Germany and must be carried at work.

If desired, this certificate can be issued in the alias name used in a valid alias certificate (§ 6).

# 2. Registration certificate according to the §3 Prostitute Protection Act at the Health Office - District Administrative Authority.

• Why do I have to register?

In order to be able to start working as a prostitute, section 3 of the Prostitution Protection Act requires registration. Registration includes an information and counseling session on the rights and obligations of prostitutes, for example, health insurance, taxes and assistance. Afterwards you will receive the registration certificate.

• Where does the registration take place?

Registration takes place in a confidential setting at the Nuremberg Health Department - District Administrative Authority, Burgstraße 4, 90403 Nuremberg, room U22a, basement, telephone number: 0911 / 231 - 77 999. Please make an appointment in advance by telephone!

- What do I need to bring with?
- current photo (passport photo 35 x 45 millimeters)
- identity card

- Proof of health consultation (see step 1). At the first registration this proof must not be older than three months

- for non-EU citizens: proof of entitlement to employment or self-employment
  - What do i have to pay?

The registration with certificate of registration costs 35 euros. If you also want a so-called "alias ID card" with your work name, another 35 euros will be due. You can pay at the ticket machine in cash or with a card.
