

# **NO BROKERAGE COMMISSION**

As a rule, no brokerage commission is due for tenancy agreements concluded in Germany. Exception: If the tenants themselves hire a professional estate agent to find a home. This commission is limited in amount. If you have not concluded an agreement, you do not have to pay anything for the brokerage of a flat or you can claim back an unjustly paid commission.



# YOUR LANDLORD CANNOT SIMPLY GIVE YOU NOTICE!

In Germany, tenants are quite well protected from being given notice on their home. If you have any problems and questions about your tenancy agreement or disagreements with your landlord, you can get support. Tenants' associations and lawyers will assist you with tenancy law issues.
